SIT Leisure Limited (“SITL”), a wholly-owned subsidiary of the Sugar Investment Trust (“SIT”), is the owner of Le Waterpark & Leisure Village (“the Waterpark”), a water-themed attraction park which has been constructed over an extent of 26 Arpents of land on the east coast of Mauritius at Belle Mare. SITL is presently renovating the Waterpark, with the refurbishment of the existing slides and addition of new attractions. The refurbishment works of the Waterpark is expected to reach completion this year and the grand re-opening of the Waterpark is scheduled for the end of 2018.
