

DIRECTIONS TO VOTERS

1. When applying for a ballot paper an elector shall produce to the Presiding Officer his new National Identity Card, Passport, Driving Licence or bus pass.
2. An elector shall vote for candidate(s) of **his respective category ONLY**.
3. Each elector will be issued with a ballot paper for his **category** and will be required to vote for not more than the number of candidates specified hereunder by putting a cross (x) opposite the name(s) of the candidate(s) of his choice.
4. If an elector votes for more candidates than the number specified hereunder or places on the ballot paper any mark or writing by which he could afterwards be identified, his votes will be void and will not be counted.
